Accordingly, the amendments effectively expand the protections of the original ADA to include more individuals with less severe impairments, which will therefore likely result in more discrimination claims filed under the ADA. This presentation will introduce the differences between the old and the new Act and the changes that employers must implement to decrease their liability under the ADAAA.
